Training

Courses are available to all employees when related to the insurance coverages purchased by the member. Safety Certification

Many VRSA Online University programs are designed to address specific requirements of the Occupational Safety and Health Administration (OSHA).

The Virginia Department of Professional and Occupational Regulations (DPOR) recognizes e-learning as an acceptable method for water and wastewater operators to maintain their certification. 50 percent of operator's required training hours can be earned on safety and health subject matter - and all of these hours can be earned through the VRSA Online University.
